

Building no. 84 has no design detail but a crack was found in a beam at 2nd floor (84 no.) of Head Office Building at Motijheel, Dhaka. A thorough and comprehensive investigation of the entire building is necessary. Consultant should have to render its consultancy services on the basis of discussion with the bank authority.</p> <p>The Consultancy services include the following:</p> <ol style="list-style-type: none">Site Survey.Structural/Architectural Drawing.Structural Analysis & Design by computer modeling (ETABS) by following the guideline of BNBC-2006.Preparation of assessment report based on detail analysis and testing of materials.Re-bar detection by scanning and report making.Preparation of tender documents.Core cutting test from reliable source, Core sample collection, refills by micro concrete (03 sets).Detail retrofitting drawings (if necessary).Re-bar test (03 sets).Preparation of a loading plan for all floor plates within the institutions given consideration to floor capacity and column.Any other related works, if required.
