Your tender must be delivered to the office of the undersigned on or before 13-02-2024 at 2.30 p.m. Any tender received later than the scheduled time will be rejected and returned unopened. The envelope containing the tender must be clearly marked Tender (LTM) for Lot-1 Supply, Installation and Commissioning of 05(Five) Pieces of Multifunction Color Ink Printer and Lot-2 Supply, Installation and Commissioning of 25(Twenty Five) Pieces of Laser Printer for Bangladesh Krishi Bank and DO NOT OPEN before 13-02-2024 at 03.00 p.m.
- 7. All tenders must be valid for a period of 60 (sixty) days from the closing date of the Tender (LTM).
- 8. In the case of any arithmetical discrepancy between the Unit Rate and the Total Amount quoted, then the Unit Rate shall prevail both for the evaluation of tenders and for the subsequent Purchase Order.
